## **NOTES ON CREW MEMBERSHIP**

- 1. Crew membership duration is from Lift In to Lift Out each year.**
- 2. Crew membership is only available to those who have never been members of the Club before.**
- 3. The Crew Member must be actively crewing on a boat owned by a member, who must propose the crew member.**
- 4. The Crew member can use the changing rooms, the launch service, the bar and dining facilities on sailing days and otherwise by arrangement.**
- 5. Crew Members may apply for lockers, and will be facilitated if lockers remain available after members have been allocated.**
- 6. Crew members may not avail of club equipment hire and courses, or book events in the Club.**
- 7. Crew members may not invite guests to the Club.**
- 8. Crew members will be issued with an Access Only membership card.**
- 9. Crew members agree to be bound by the Rules and Bye Laws of the Club**
- 10. Attention is directed to the GDPR consent – the crew member agrees to the use of the data provided on this form to administer the Crew Membership.**
- 11. Should the Crew Member be proposed and accepted as an Introductory Member in the year of his crew membership, the Crew Membership Subscription will be credited against the Introductory Membership Subscription.**
